Converting Short-term Coursetakers to Graduates Kathy Booth, Project Director, Education Data and Policy, WestEd

Kathy Booth from WestEd and Peter Bahr from the University of Michigan are leading a body of research in Ohio and Colorado examining the coursetaking behavior of adult students, in particular, adult students who enroll in a small number of 'skills-building' courses. The goal of their research is to understand how adult students are leveraging short-term course-taking to improve earnings, who is benefitting from this type of training, how outcomes vary by program of study, and how skills-builder course-taking relates to stackable credential pathways. Kathy will preview the research and also discuss how WestEd will support an analysis of the 'skillsbuilders' for the colleges in our cohort between Institute #2 and Institute #3.

(ACIP) Framework for Onboarding into Programs of Study

To help more students gain early momentum, community colleges need to reimagine new student onboarding with a focus on helping students enter a program of study aligned with their interests, strengths, and aspirations. CCRC has demonstrated how "onboarding" is a process that may take students' entire first year: It starts before a student even enrolls and extends until they have chosen a program direction, passed program foundation courses, and created an educational plan. The goal is to help students choose a program of study; connect with a community of faculty, students, and others with similar interests; take a course that "lights their fire" for learning, and build a full-program educational plan that shows the courses and timeline for completion. Hana will provide an introduction to the ACIP Framework, which will then be expanded upon in Institute #3.

Equity and economic competitiveness needs to be considered from both a structural lens and a human lens.
